## SPECIAL EDUCATION AND YOUR CHILD: OVERVIEW

School District: legal obligation to provide an appropriate program

- More resources than parents
- Team of attorneys, psychologists, administrators

Parents: often the 'Underdog' and Advocate

Preparation and knowledge are Key.

**Springtime**: Annual meetings take place to finalize the Program for the following school year

## WHAT IS "FAPE?"

Free Appropriate Public Education

A - "Appropriate." It does not mean "Optimal"

- School districts are not required to maximize a child's academic progress
- What does it mean to be "appropriate"?

# CASE LAW: WHAT IS "MEANINGFUL PROGRESS?"


# A child must make 'meaningful progress' across all areas.

- Academic
- Social
- Emotional
- Behavioral



# SCHOOL ACRONYMS

Special Education can be a "Foreign Language" to parents



## **COMMITTEE ON SPECIAL EDUCATION**

#### Meeting at least once a year

#### Convened to review your child's program

- Parents face multiple school district staff
- Intimidation (Parents vs. A Bunch of Professionals)
- Development of the Individualized Education Program, "IEP"



## HOW TO PREPARE FOR YOUR C.S.E.



Jacob's Top Ten
Tips to a
Successful
Outcome

## 1. EVALUATIONS

#### Consider having your child privately evaluated

Some insurance will cover it

#### Request an Independent Educational Evaluation - "IEE"

Funded by District

### Evaluation shows where child is struggling and their functional levels

- Includes recommendations
- Written report provided to parents prior to the CSE

## 2. PAPER TRIAL

#### Parents Should Write to the CSE Rather Than Call

#### Make Sure You Have a Paper Trail

- Put concerns in writing
- Summarize info discussed in phone calls with an email after the call

### Don't Wait Until a Meeting to Air Issues

- -Puts district on defensive
- -Less likely to have productive conversations



## 3. INVITE PEOPLE TO YOUR CSE

### You Have the Legal Right to Invite Anyone

- Private Evaluator
- Therapist
- Doctor
- Tutor
- Family Members

#### **Accommodations Can Be Made Available:**

- In Person
- By Zoom
- By Phone

## 4. BRING AN ADVOCATE OR AN ATTORNEY

It's an Emotional and Personal Process

Don't be intimidated by 5-10 District staff

#### Consider including an Advocate or Attorney

- Translate technical terms
- Knows your child's rights
- More objective; can challenge or negotiate without emotion

## **5. ASSERT YOURSELF**

- State your concerns
- Do not agree just to be nice
- Ask for more information
- If you don't agree to terms, ask for more time
- If needed, get a second opinion



## 6. ONE CSE MEETING IS NOT ALL YOU GET

- One annual meeting with the District is not the only one you are allowed
- Parents can call for a new CSE meeting at any time
- No time limit on length of meeting

## 7. TRIENNIAL REEVALUATIONS



By law, a student must be evaluated a minimum of every 3 years.

## 8. RIGHT TO PENDENCY

If child's program gets changed and you disagree: Assert Pendency

- Program cannot be changed until you are granted a hearing has concluded
- Allows child to get "last agreed-upon program" for up to another year or more

## 9. TAKE GOOD NOTES

## Bring someone to CSE to take notes

- Allows you to focus and participate
- The notes can be compared to the new IEP to ensure all services and supports made it into the IEP



## HOW TO READ AND INTERPRET THE IEP

## The 3 Key Sections Are:

- A. Present Levels of Performance
- B. Recommended Special Education Program and Services Example: "15 : 1+1"
- C. Measurable Goals



## 10. FOLLOW UP AND SUMMARIZE



## Following your CSE Meeting:

- Summarize discussion and decision in writing
- Once you receive the IEP, detail corrections or disagreements
- Send correspondence to the CSE
